1. NAME OF THE SOCIETY: The name of the society shall be

2. REGISTERED OFFICE OF THE SOCIETY:

3. AIMS AND OBJECTS OF THE SOCIETY: Runs Schools & Colleges namely KAY JAY COLLEGE OF EDUCATION, KAY JAY COLLEGE OF PHARMACY AND TECHNOLOGY AND KAY JAY INTERNATIONAL SCHOOL.

Aims & objects of the society for which the same is established are as Under :-

- a) To start establish, promote, run on Charitable basis, take over or manage and maintain school, colleges secondary, senior secondary and higher education to children by seeking, recognition and affiliation from education departments Indian Govt. Authorities and overseas Educational Authorizes.

- c) To tie-ups with various Banks, Financial Institutions Trusts, corporate and sponsors to arrange interest bearing and interest free educational loans for needy students.
- d) To institute scholarship and helping to deserving students and to institute and award prize for their excellence academic performance.
- e) To award appropriate certificates or diplomas in respect of educational, vocational or technical course administered and carried out by the society.
- f) To publish Books, Charts, Illustrations, Journals, Magazines, Periodicals, Newsletters/papers and other publication in different languages on different subjects of Immigration Rules, Visa Rules Passport, Business visa, Educational Visa and other services relating to foreign travel.
- g) To start create, launch and maintain web-site on different subjects of Immigration Rules, Visa Rules, Passport, Business Visa Educational Visa and other services relating to foreign travel with tie-ups various embassies
- h) To starts, establish promote run, take over or manage and maintain information service centre in regard to information about Immigration Rules. Visa Rules, Passport, Business Visa, Educational Visa and other service relating to foreign travel.
- i) To open start, establish, promote, set-up run, maintain, assist-finance, support and/ Or help the various community development program/activities to promote Health care centre, Child Health care centre, Old age Homes, Night shelters for old & Poor, Dharamshala, Charitable Dispensaries, Reading Rooms, Library, Yoga

- Training Centre and Nrityalay and other building/ Institutions for the upliftment and betterment of the members of the society and for the General Welfare of the Public.
- j) To make adequate arrangements and starts and start the rehabilitation the charitable and professional goal for standardizing the working of institutes run by the society.
 - k) To receive subscription/ donation and grant for accomplishing the charitable and professional goal for standardizing the working of Institutes run by the society.
 - l) To open centers/institutes for diagnostic, curative and research for cancer, Aids and other deadly diseases and conduct awareness programs regarding these.
 - m) To promote literacy, cultural and other social activities by awareness programs, adult Education classes, Lectures, Essay Competitions, Exhibitions.
 - n) To provide, food, clothes, medical aid, stationary, Transportation, Libraries, Laboratories, Reading Rooms, Hostels, Play Grounds, Swimming Pool and other possible facilities to the members and also to the members of the society.
 - o) To invite the applications from the various Institutions for the franchise to use the name of the society.
 - p) To promote fine art, craft among the public including establishment and maintenance of Shipla, Shikshalay, Kala Kendra (relating to Music, Dance, Modeling, Painting Etc.
 - q) To follow the ideology of great Men and National Leader who sacrificed their lives for the causes of depressed, deprived, SC, St Backward Classes, Minority Groups and other needy people.
 - r) To take up effective but reason a bland lawful steps for the eradication of social evils such as Dowry System, Child Marriage, Child Labor, Wastage of Money in the various functions and use of intoxicated drugs/wines/smack etc.
 - s) To give, provide and/ or render monetary and/or other help and assistance for the relief of persons and animals affected by natural other calamities such as flood, fire, famine, cyclone, earth quake, storm, accident, pestilence, drought, epidemic, Unbearable cost of living and the like give donations, subscriptions or contributions to Institutions, establishments, centers or persons doing relief work on such occasion.
 - t) To start various programs against child labor and take up effective but reasonable and lawful steps on this connection for the welfare of children.
 - u) To work for promotion and diffusion of useful knowledge and advancement of Indian art, Culture and Philosophy.
 - v) To engage, employ or hire appropriate Doctor, Nurses, Staff, workers, Legal experts, Accountants and other professionals, Chartered Accountants, Attorneys, Managers and Agents for the work and furtherance of the aims and objects of the society and to pay their wages, salaries, stipends or fees.
 - w) To receive financial and non-financial assistance from Govt. Non-Govt organization, Internationals Agencies, Banks and any other legal entity or individual
 - x) To borrow or receive money (With interest or without interest) and upon such term and conditions as are approved by the Governing Body or Society.
 - y) To accept donations, Grants, Presents, Gifts and other offerings in the shapes of moveable and /Or immovable properties for the attainment of the aims and objects of the society.
 - z) To erect, construct, alter maintain, sell, lease, mortgage, transfer, Improve, develop, manage and control all or any part of the property or the building of the above society, necessary or convenient for the purpose of the attainment of the aims and objects of the society
 - aa) To do such other things/acts/activities which are necessary and which may be incidental or conducive to the attainment of any of the objects of the society.

- bb) The aim & objects of the society shall be purely for CHARTABLE PURPOSE. This includes relief of the poor, Educational, Social medical relief and the advancement of any other objects of the general public utility.
- cc) All the acts/activities shall be non-profitable and shall be done on NO PROFIT NO LOSS basis.
- dd) The society will invest its money and funds according to the section-11(5) of the income Tax Act, 1961.
- ee) To make arrange and organize Dance & Drama competition to prove the efficiency of the different dance & drama groups of the welfare and entertainment of the common people and to encourage the artists.
- ff) To arrange & organize for star Night programs and Charitable shows to collect funds for the development and upliftment of the society and make Educational Documentary Films as per the requirement and norms of Govt. Rules & schemes.
- gg) To make Films and play Dramas etc. For the scheme of developing the social, religious and educational, cultural polices of Govt. Of India for the awareness of common public.
- hh) All the income, earning, moveable or immoveable properties of the society shall be solely utilized and applied towards the promotion of its aims and objects only as set forth in the Memorandum of the Society and no profit thereof shall be paid or transferred directly or indirectly by way of dividends. Bonus, profits in any manner what so ever to the present or the past members of the Society or to any person claiming through anyone or more of the present or the past members. No members of the society shall have any profits whatsoever by virtue of the membership.
